

MEMORANDUM FOR ALL MILITARY AND CIVILIAN PERSONNEL

SUBJECT: Garrison Commander's Policy Memorandum No. 42 - Appeal of Suspended Driving Privileges and Consideration of Restricted Driving Privileges for Other than Intoxicated or Impaired Driving

1. USASIGCoE and Fort Gordon Regulation 210-3, *Installation Motor Vehicle Traffic Code*, establishes responsibilities and provides instructions for the suspension of driving privileges on Fort Gordon, in accordance with Army Regulation (AR) 190-5, *Motor Vehicle Traffic Supervision*.
2. The Provost Marshal (PM) immediately suspends installation driving privileges for persons who drive on the installation with suspended driving licenses. Affected drivers may request hearings for review of the PM's immediate suspension and other suspensions for other than intoxicated or impaired driving offenses. OSJA, Administrative and Civil Law Division, conducts the hearings and submits reports to the Deputy Staff Judge Advocate (DSJA) or Staff Judge Advocate (SJA) for decision, which the affected driver may appeal to the Garrison Commander. Appeals must be forwarded through OSJA to the Garrison Commander within 14 calendar days after the affected driver receives the DSJA's or SJA's decision. The suspension will remain in effect while the appeal is being considered.
3. Requests for restricted driving privileges for other than intoxicated or impaired driving are forwarded through OSJA, Administrative and Civil Law Division, to the Garrison Commander. Military personnel must include recommendations from the chain of command. Requests from civilians are also forwarded through OSJA to the Garrison Commander. All such requests must meet the minimum requirements of AR 190-5, paragraph 2-10. The Garrison Commander's review is based on the written record developed by OSJA and as supplemented by any additional relevant information the affected driver submits.
