Employees who generate or handle prepare for shipment, manifesting or manage hazardous waste.	<b>Hazardous Waste Management Refresher</b> <i>40CFR 265.16</i>	Annually
Employees whose work activities may contact asbestos containing material (ACM) or presumed asbestos containing material (PACM) but do not disturb the ACM or PACM during their work activities.	<b>Asbestos Awareness Training</b> <i>29 CFR 1910.1001</i>	Prior to or at the time of initial assignment and at least annually thereafter.
All employees involved in oil handling activities	<b>Spill Prevention Control and Countermeasure Training</b> <i>40 CFR Part 112</i>	Receive 8 hour initial facility specific training.  4 hour annual refresher training
Personnel who work in Stormwater Industrial Facilities, & motorpools.	<b>Stormwater Industrial Training – 4hrs</b> <i>40 CFR Part 112</i>	Annually
